4. You are also requested to comply the following:

- a) Rain water conservation measures notified by CMDA should be adhered to strictly.
- b) 5 sets of Revised Plan as on site condition along with terrace floor plan
- c) Notorised undertaking deed.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
