The proposal for the construction of residential

However, on request of the applicant, three copies of the duly  
attested "TRUE COPY" of the approved plans (numbered as  
A/27395/202/2000) along with two copies of duly attested Xerox  
copies of the Planning Permit are sent herewith for taking  
necessary further action at your end.

The true copies of approved plans and planning  
permit should be treated as original Approved Plan and  
Planning Permit.
