The Planning Permission application received in the reference cited for the proposed construction of Ground floor + 3 floors Residential building with 8 Dwelling units at S.No. 98/1I and 98/1A2 of Madanandapuram village, Porur, Chennai-116 is under scrutiny.

To process the applicant further, you a re requested to remit the following by five SP Separate Demand Draft of a Nationalised Bank in Chennai City drawn in favour of Member Secretary, Chennai Metropolitan Development Authority, Chennai -8, at Cash counter (between 10.00 A.M. and 4.00 P.M.) in CMDA and produce the duplicate receipt to the Area Plans Unit, 'B' Chennal in CMDA.

- i) Development charges for land and building under Sec.59 of T&CP Act, 1971
- : Rs. 10,200/-(Rs. Ten thousand and two hundred only)

ii) Scrutiny Fee

Rs. 500/-(Rs. Five hundred only) iii) Regularisation charges : Rs. 13,000/-

(Rs. Thirteen thousand only)

iv) Open Space Reservation charges (i.e. equivalent land cost in lieu of the space to be reserved and handed over as par DCR 19(b)I(VI)19(b)-II(vi)/ 17(a)-9)

v) Security Deposit (for the roposed development : Rs. 39,000/- (Rs. Thirty nine thousand only)

- vi) Security Deposit (for septic : Rs. 8,000/tank with uoflow filter) (Rs. Eight thousand only)
- vii) Security Deposit(for Display : Rs. 10,000/-Board) (Rs. Ten thousand only)
- NOTE: i) Security Parasits are refundable amount without interest an claim, after issue of completion certificate by CLDA. If there is any deviation/violation/change of use of any part or whole of the building/site to the approved plan security deposit will be forfeited.
 - ii) Security Deposit for Display Board is refundable when the Display Board as prescribed in the format is put up in the site under reference. In case of default security deposit will be forfeited and action will be taken to put up the Display Board.
 - iii) In the event of unclaim of the Security Deposit for a period of more than 5 years, it is presumed that the applicant may not have any right to claim the same and the amount would be forefeited.
- 2. Payments received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits).
- 3. The papers would be returned unapproved . if the payment is not made within 60 days from the date of issue of this letter.

- 4. You are also requested to comply the following:
- a) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DCR 2(b)II:-
 - The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - ii) In cases of Special Buildings, Group Developments, a professionally qualified Architect Registered with council of Architects or Class -I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters a hould be furnished.
 - Architect/Class Thicensed surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CADA when the building has reached upto Plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved than.

 The Licensed surveyor and Architect shall inform this Authority inschiately if the contract between him/them and the carefleeveloper has been cancelled or the construction is carried out in deviation to the
 - iv) The owner shall inform C:DA of any c hange of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CIDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointee.

- v) On completion of the construction, the applicant shall intimate CLDA and shall not occupy the building or permit it to be occupied until a completion cartificate is obtained from CPDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate issued by C.DA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of Sale/lease or any other means to any person before completion of the construction, the party shall inform CPDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.

- viii) In the Open space within the site, trees should be planted and the existing trees presserved to the extent possible.
 - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
 - x) The new building should have mosquito proof over head tanks and wells.
 - xi) The sanction will be avoid abinitio, if the conditions mentioned above are not complied with.
- xii) Rain water conservation measures notified by C:DA should be adhered to strictly:
 - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs.10/- stamp paper duly executed by all the land owners, GPA Holders, builders and promoters separately. The Undertakings shall be duly attested by a Notary Public.
 - b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.

5. You are also requested to furnish the following the particulars:

- 1. Revised plan rectifying the following defects:
 - a) Both the training boundary dimensions as per the Field Measurement Book sketch and as on site condition should be shown in the site plan and distinguishing the difference in area by hatching and leaving required set back at the minimum point arrived.
 - b) Total height of the structure has to be mentioned in the elevation.
 - c) Revised plan satisfying the turning radius for the Car parking.
- Design calculation for the Septic tank and sewage upflow filter has to be furnished alongwith the plan.

6. The issue of Planning permission depend on the compliance/fulfilment of the conditions/payments stated above. The acceptance by the Authority of the prepayment of the Development charge and other charges etc., shall not entitle the person to the Planning permission but only refund of the Development charge and other charges (excluding scrutiny fee) in case of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other person provided the construction is not conneced and claim for refund is made by the applicant.
