The Planning Permission Application and Revised Plan received in the reference 1st and 2nd cited for the construction of Stilt parking floor + 4 Floors residential building with 16 dwelling units at Plot No.12 and 13, 4th and 5th Main Road, Kasthurba Nagar, T.S.No.20, 21/1&2, Block No.10, Pallipattu, Chennai has been approved subject to the conditions incorporated in the reference 3rd cited. Copy to Cmnda. (nsiq bevoiqs)

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 5th cited and has remitted the necessary charges in Challan No. A-6491, dated 29.05.2001 including Security Deposit for building Rs.64,000/- (Rupees sixty four thousand only) and Security Deposit for Display Board of Rs.10,000/- (Rupees ten thousand only) in cash.

3(a) The applicant has furnished a Demand Draft in favour of Managing Director, CMWSSB, for a sum of Rs.80,100/- (Rupees eighty thousand and one hundred only) towards Water Supply and Sewerage Infrastructure Improvement Charges in his letter dated 28.05.2001.

(b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

(c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confirmed to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all walls, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.
