- iii) A report in writing shall be sent to CIDA by the Architect/Class -I Licensed surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CADA when the building has reached upto Plinth level and thereafter every three months at various stages of the construction/ development certifying that the work so far completed is in accordance with the approved plan. The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/ them and the owner/developer has been cancelled or the construction is carried out in deviation to the
  - iv) The owner shall inform CIDA of any c hange of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CIDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointee.

- v) On completion of the construction, the applicant shall intimate CIDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CNDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate issued by C.DA along with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of Sale/lease or any other means to any person before completion of the construction, the party shall inform CTDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.

- viii) In the Open space within the site, trees should be planted and the existing trees presserved to the extent possible.
  - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
    - x) The new building should have mosquito proof over head tanks and wells.
  - xi) The sanction will be avoid abinitio, if the conditions mentioned above are not complied with.
  - xii) Rain water conservation measures notified by CDA should be adhered to strictly:
    - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs.10/- stemp paper duly executed by all the land owners, GPA Holders, builders and promoters separately. The Undertakings shall be duly attested by a Notary Public.
    - b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.
