 - ii) In cases of Special Buildings, Group Developments a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be assocated with the construction work till it is completed. Their names/addressess and consent letters should be furnished.

i) A report in writing shell be sent to CMDA by the Architect / Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CNDA when the building has reached unto Plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract netween him/them and the owner developer has been cancelled or the construction is carried out in deviation to the approved plan.

- The owner shall inform CMDA of any change of the Licensed Surveyor / Architect. The newly appointed Licensed Surveyor / Architect shall also confirm to CMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department / Board / Agency.
- vii) When the site under reference is transferred by way of Sele / lease or any other means to any person before completion of the construction, the party shall inform CHDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.
- viii) In the Open Space within the site, trees should be planted and the existing trees preserved to the extent possible.
 - ix) If there is any false statement, suppression or any mis-representations of acts in the application planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
 - x) The new building should have mosquito proof over Head Tanks and Wells.
