The Planning Permission Application/Revised Plan received in the reference 1st and 2nd cited for the proposed construction of Ground+3 Floors (8 dwelling units) residential building at Plot No.44 and 45 part, T.S.No.12/2, Block No.35, Door No.21, Kalaizhar Karunanidhi Salai, Kaveri Ranga Nagar, Saligramam village, Chennai has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Challan No.A-6638, dated 08-06-2001 including Security Deposit for building Rs.32,800/- (Rupees thirty two thousand eight hundred only) and Security Deposit for Display Board of Rs.10,000/- (Rupees ten thousand only) in cash.

3. a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs.39,500/- (Rupees thirty nine thousand five hundred only) towards Water Supply and Sewerage Infrastructure Improvement charges in her letter dated (Nil) 08-06-2001.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction she can commence the internal sewer works.

c) In respect of Water Supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermetically sealed of with properly protected vents to avoid mosquito menace.
