The Planning permission Application/Revised plan received in the reference First cited for the construction of Residential Building Stilt, Ist to IVth floor with 8 Dwelling unit, Door No.43, Plot No.838-A, 4th Street, A.A.Nagar East, T.S.No.14/4, Block No.7 Periyakudal village, Chennai has been approved subject to the conditions incorporated in the reference second cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference third cited and has remitted the necessary charges in Challan No.9664, dated 22-11-2000 including Security Deposit for building Rs.46,000/- (Rupees Forty six thousand only) and Rs Security Deposit for Display Board of Rs.10,000/- (Rupees Ten thousand only)

3.a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water supply & Sewerage Board, for a sum of Rs.53,000/- (Rupees fifty eight thousand only) towards Water supply and Sewerage Infrastructure Improvement charges in his letter dated 22-11-2000.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro water and only after due sanction he can commence the internal sewer works

c) In respect of water supply, it may be possible for Metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.
