

Their names/addressess and consent letters should be furnished. a gala man

- iii) A report in writing shall be sent to CMDA by the Architect / Class-I Licensed Surveyor who supervises the construction is just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached upto Plinth level and therester every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.
 - The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.
- iv) The owner shall inform CMDA of any change of the Licensed Surveyor / Architect. The newly appointed Licensed Surveyor / Architect shall also confirm to CMDA that he has agreed for supervising the work under reference and intimate the sat stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- wil) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department / Board/Agency.
- vii) When the site under reference is transferred by way of Sale/
 Lease or any other means to any person before completion of
 the construction, the party shall inform CMDA of such transsection and also the name and address of the persons to whom the
 site is transferred immediately after such transaction and
 shall bind the purchaser to those conditions to the planning
