- ii) Security Deposit for display Board, is refundable when the display board as prescribed in the format is put up in the site underreference. In case of default Security Deposit will be forfeited and action will be taken to put up the Display Board.
- iii) In the event of the Security Deposit is rot claimed within a period of 5 years from the date of remittance, the Security Deposit shall beforfeited without any future notice.
- 2) Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits).

 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.

- ii) In cases of Special Buildings, Group Developments, a professionally qualified Architect Regostered with Council of Architects or Class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names/addresses and consent letters should be furnished.
- iii) A report in writing shall to sent to CMDA by the Architect/
 Class-I Licensed Surveyor who supervises the construction
 just before the commencement of the erection of the
 building as per the sanctioned plan. Similar report shall
 be sent to CMDA when the building has reached upto plinth
 level and thereafter every three months at various stages
 of the construction/development certifying that the work
 so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- The owner shall inform CMDA of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the newly appointed.
- on completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a complete certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/Board/Agency.
- Vii) When the site under reference is transferred by way of Sale/Lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to these conditions to the planning permission.
- viii) In the Open Space within the site, trees should be planted and the existing trees preserved to the extent possible.

ix) If there is any false statement suppression or any misrepresentations of acts in the application planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.

- x) The new building should have mosquito proof over head tanks and wells.
