The Planning Permission Application/Revised Plan received
in the reference 1st and 2nd cited for the proposed construction/
development at Deer No.3, 1st Cross Street, Indira Nagar, Chennai-20
has been approved subject to the conditions incorporated in the
reference 3rd cited.

2) The applicant has accepted to the conditions stipulated
by CMDA vide in the reference 4th cited and has remitted the necessary
charges in Challan No.283 dt.12.7.2001 including S.D. for building
Rs.55,200/- (Rupees fifty five thousand two hundred only) and S.D.
for display board of Rs.10,000/- (Rupees ten thousand only) in cash.

3.a) The applicant has furnished a Demand draft in favour
of the Managing Director, CMSSB for a sum of Rs.68,100/- (Rupees
sixty eight thousand one hundred only) towards water supply and
Sewerage Infrastructure Improvement charges in his letter dated
11.7.2001.

b) With reference to the sewerage system the promoter
has to submit the necessary sanitary application directly to Metro
Water and only after due sanction he/she can commence the internal
sewer works.

c) In respect of water supply, it may be possible for
Metro Water to extend water supply to a single sump for the above
premises for the purpose of drinking and cooking only and confined
to 5 persons per dwelling at the rate of 10 lpcd. In respect of
requirement of water other uses, the promoter has to ensure that he/
she can make alternate arrangements. In this case also, the promoter
should apply for the water connection, after approval of the sanitary
proposal and internal works should be taken up only after the approval
of the water application. It shall be ensured that all walls, over-
head tanks and septic tanks are hermetically sealed off with properly
protected vents to avoid mosquito menace.

4) Two copies/sets of approved plans numbered as Planning
Permit No.B/Spl.Bld/268/2001 dt.19.7.01 are sent herewith. The
Planning Permit is valid for the period from 19.7.2001 to 18.7.2004.
