The Planning Permission Application/Revised Plan received in the reference 1st and 3rd cited for the proposed construction of stilt+3Floor community hall cum residential building with 4 dwelling unit at T.S.No.115/1&2, Block No.4, Senjeri village, plot No.25(A&B) Kaliyaman Koil Street, Virugambakkam, Chennai-600 092 has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Chalan No.B-951, dt. 10.8.2001 including security deposit for building Rs.30,500/- (Rupees Thirty thousand and five hundred only) and security Deposit(Display Board) of Rs.10,000/- (Rupees Ten thousand only) in cash.

3.a. The applicant has furnished a Demand Draft in favour of Managing Director, CMWSR for a sum of Rs.36,250/- (Rupees Thirty six thousand and two hundred and fifty only) towards Water Supply and Sewerage Infrastructure Improvement charges in his letter dt. 7.8.2001.


b. With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro ~~xxx~~ water and only after due sanction he can commence the internal sewer works.

c. In respect of water supply, it may be possible for Metro Water to extend water supply to a single tap for the above premises for the purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensure that all walls, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4. Two copies of approved plans numbered as planning permit No. B/Spl. Building/331/2001, dt. 3.9.2001 are sent herewith. The Planning Permit is valid for the period from 3.9.2001 to 2.9.2004.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
