Sub: CMDA - Planning Permission - Proposed construction of GF+3F (12 dwelling units) residential building at Plot No. 6/13, Mogappair Village West Main Road, Chennai, S.No. 496/14B, Block No. 6, Mogappair Village - Approved - Regarding.

The Planning Permission Application and Revised Plan received in the reference 1st and 4th cited for the proposed construction of Ground+3 Floors (12 dwelling units) residential building at Plot No. 6/13, Mogappair West Main Road, Chennai-50, Survey No. 496/14B, Block No. 6, Mogappair Village has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 3rd cited and has remitted the necessary charges in Challan No. B-8632, dated 12-02-2002 including Security Deposit for building Rs. 35,000/- (Rupees thirty five thousand only) and Security Deposit for Display Board of Rs. 10,000/- (Rupees ten thousand only) in cash.

3. a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board, for a sum of Rs. 41,500/- (Rupees forty one thousand five hundred only) towards Water Supply and Sewerage Infrastructure Improvement charges in her letter dated 13-2-2002.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace.

4. Two copies/sets of approved plans numbered as Planning Permit No. B/Spl. Bldg./127/2002, dated 10-05-2002 are sent herewith. The Planning Permit is valid for the period from 10-05-2002 to 09-05-2005.

5. This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
