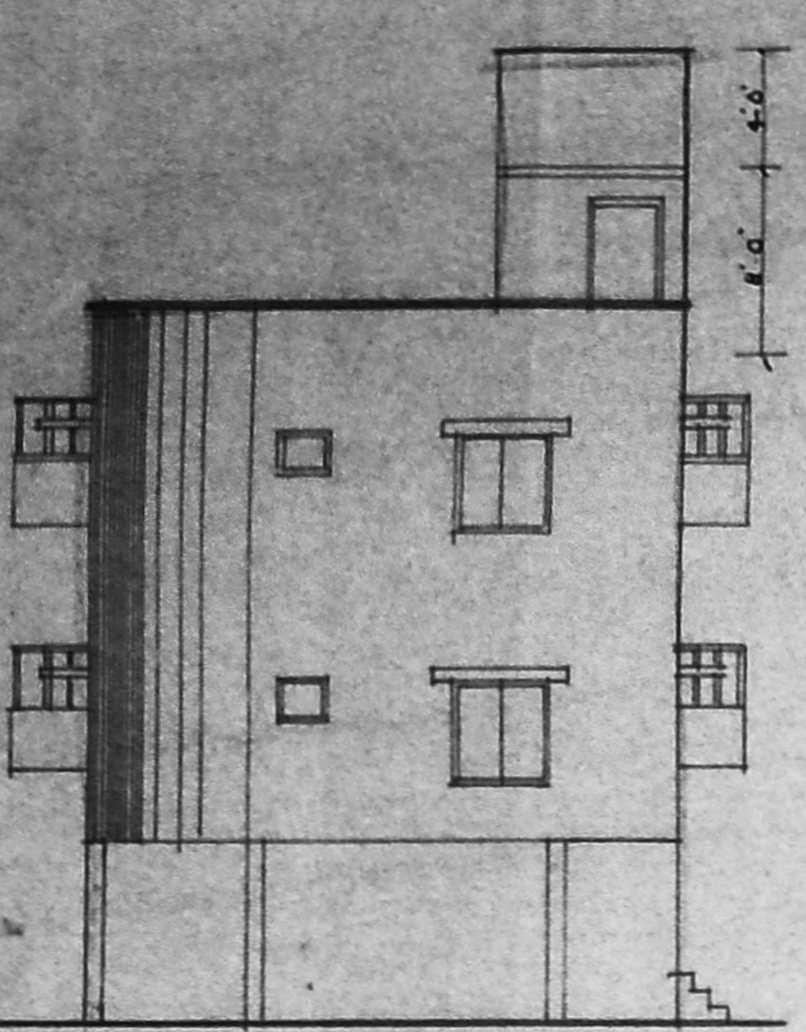

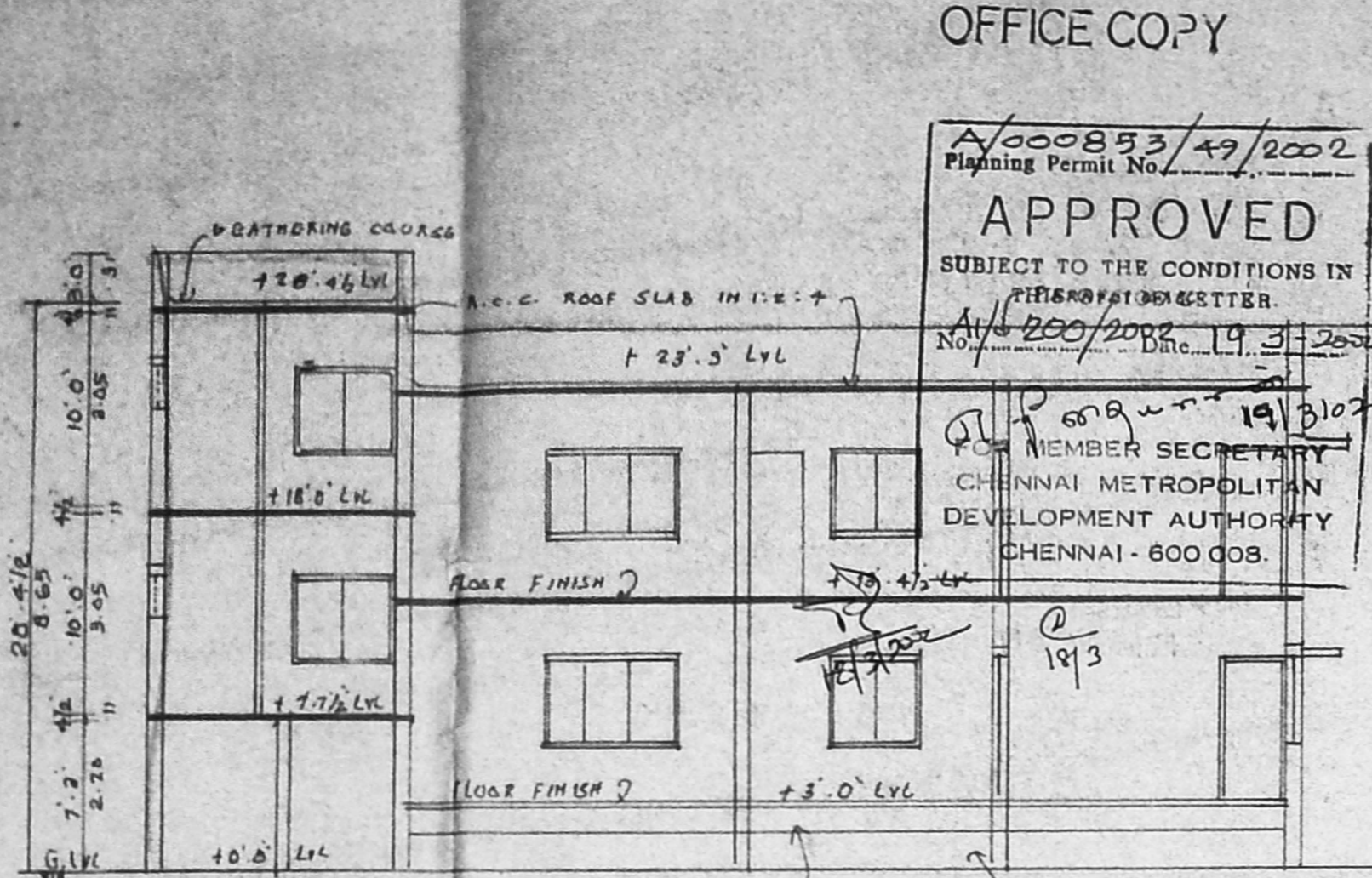

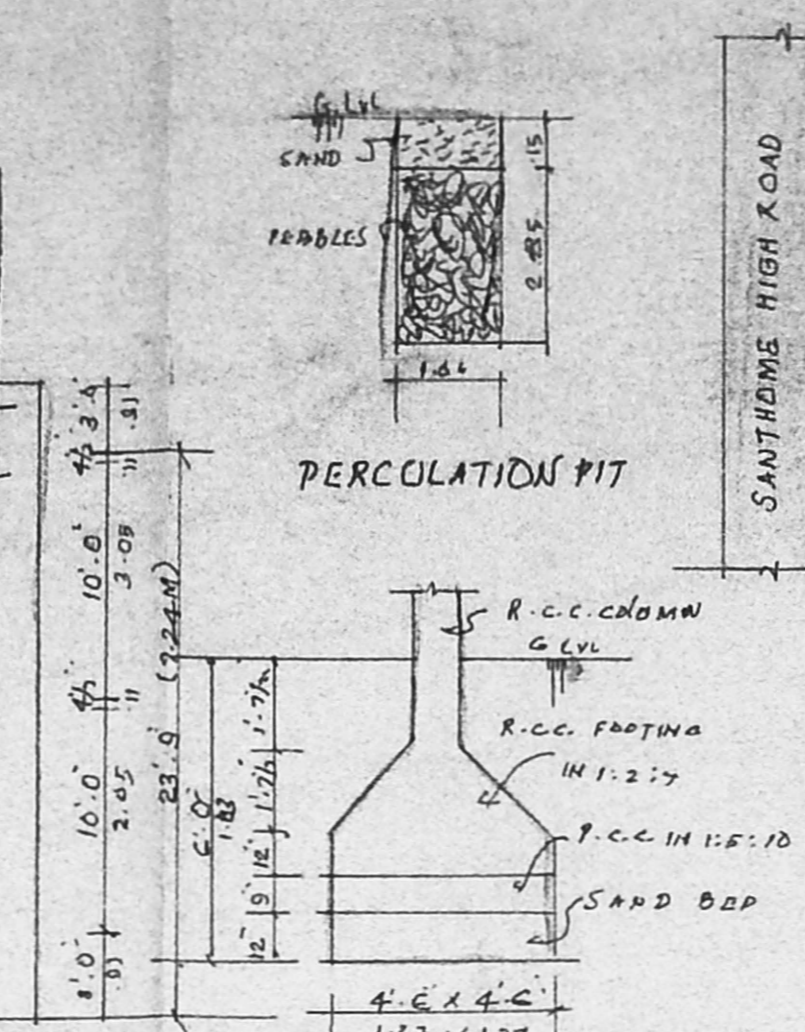

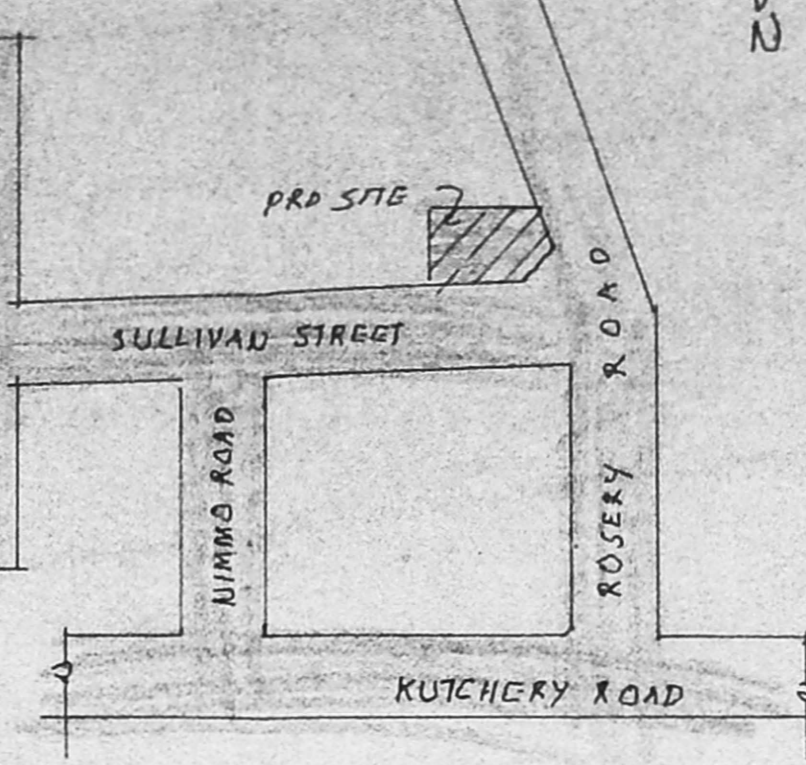

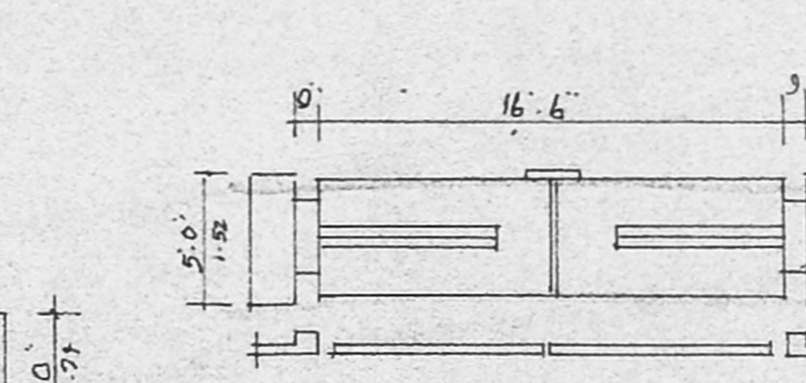

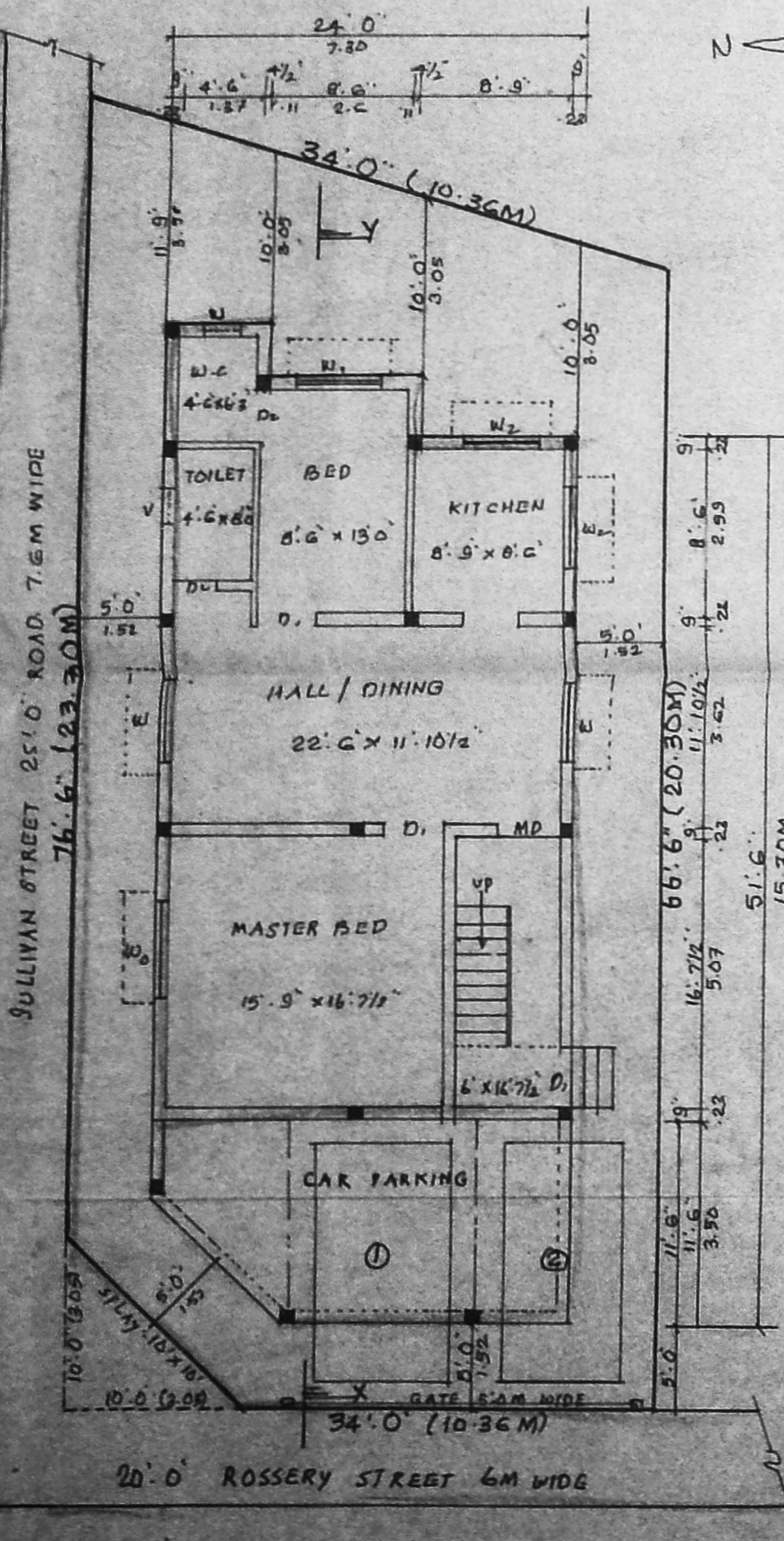

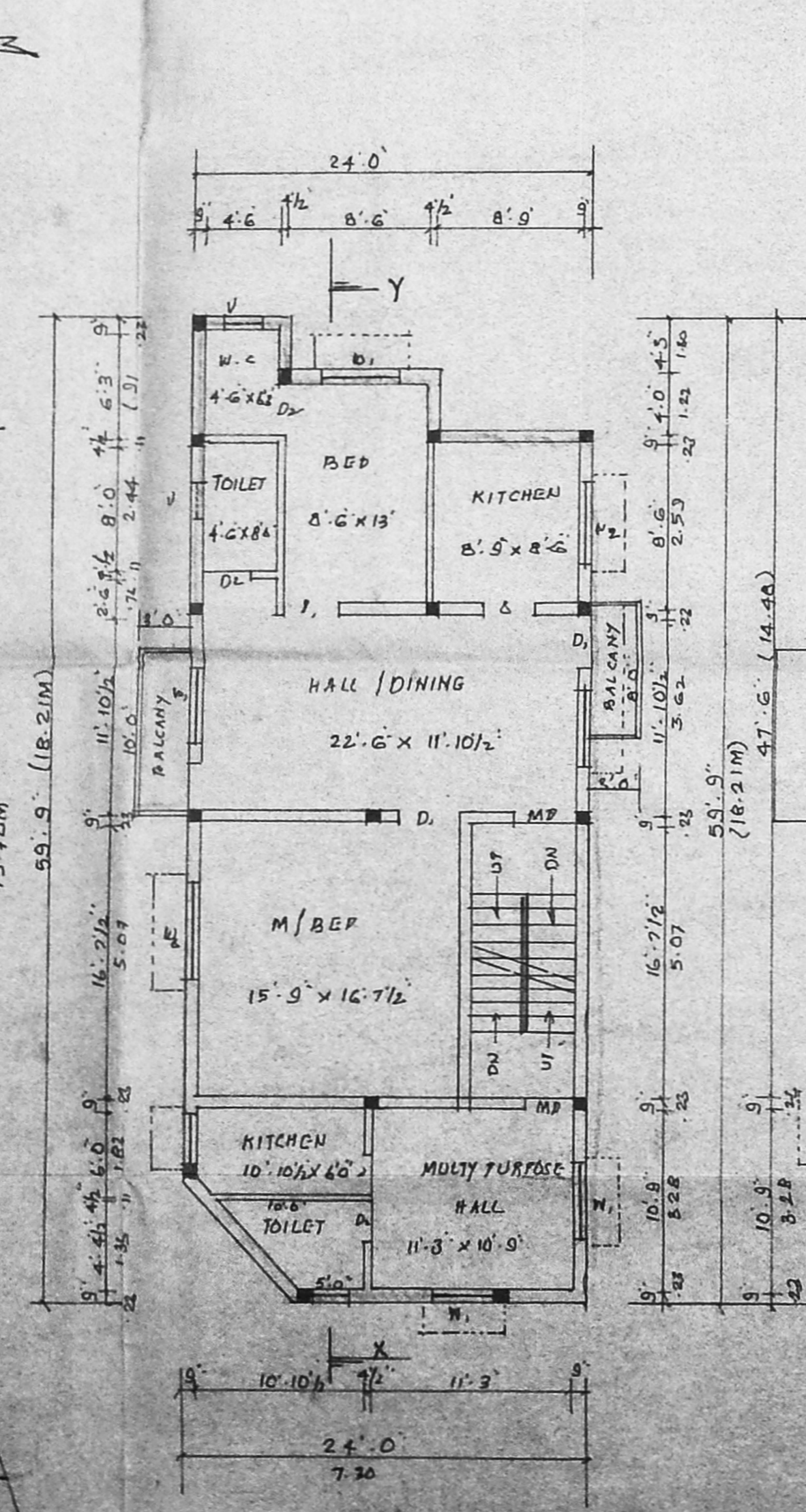
KEY PLAN NTS



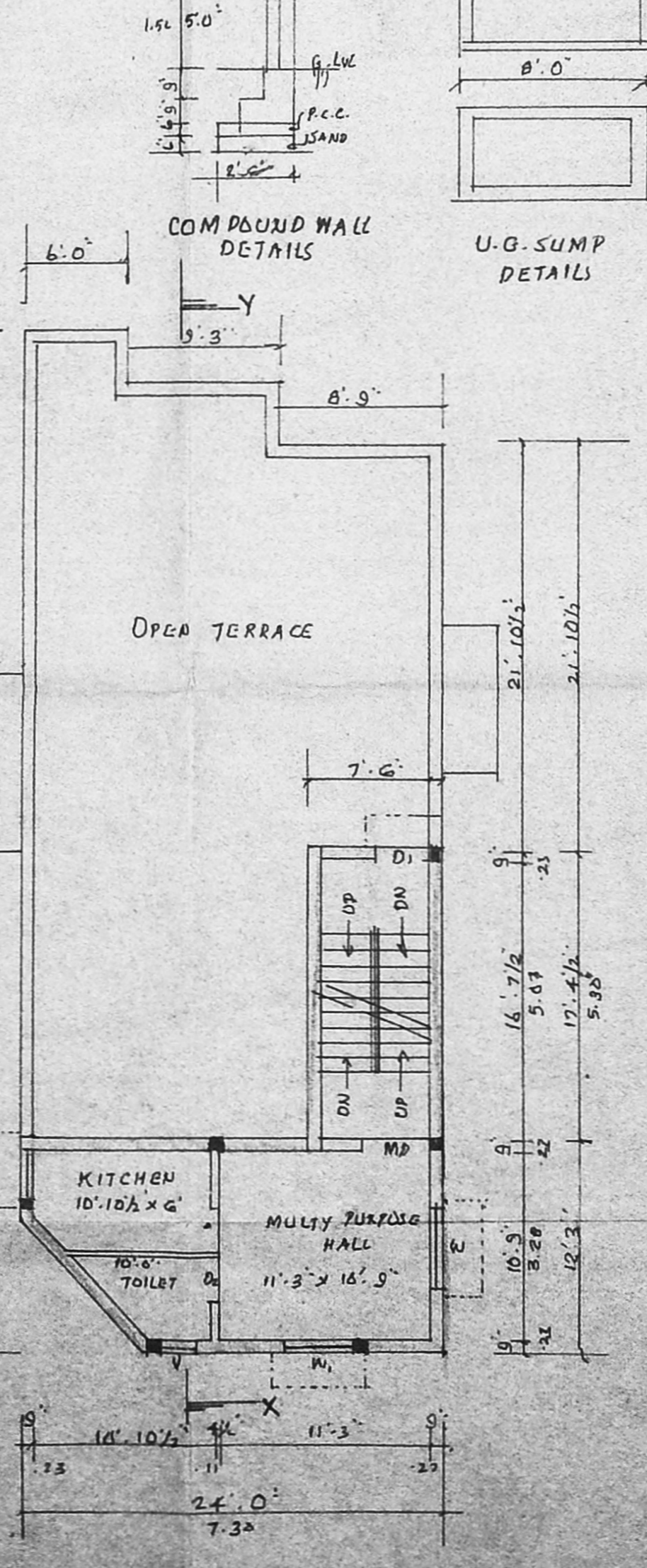
GATE PLAN & ELEVATION



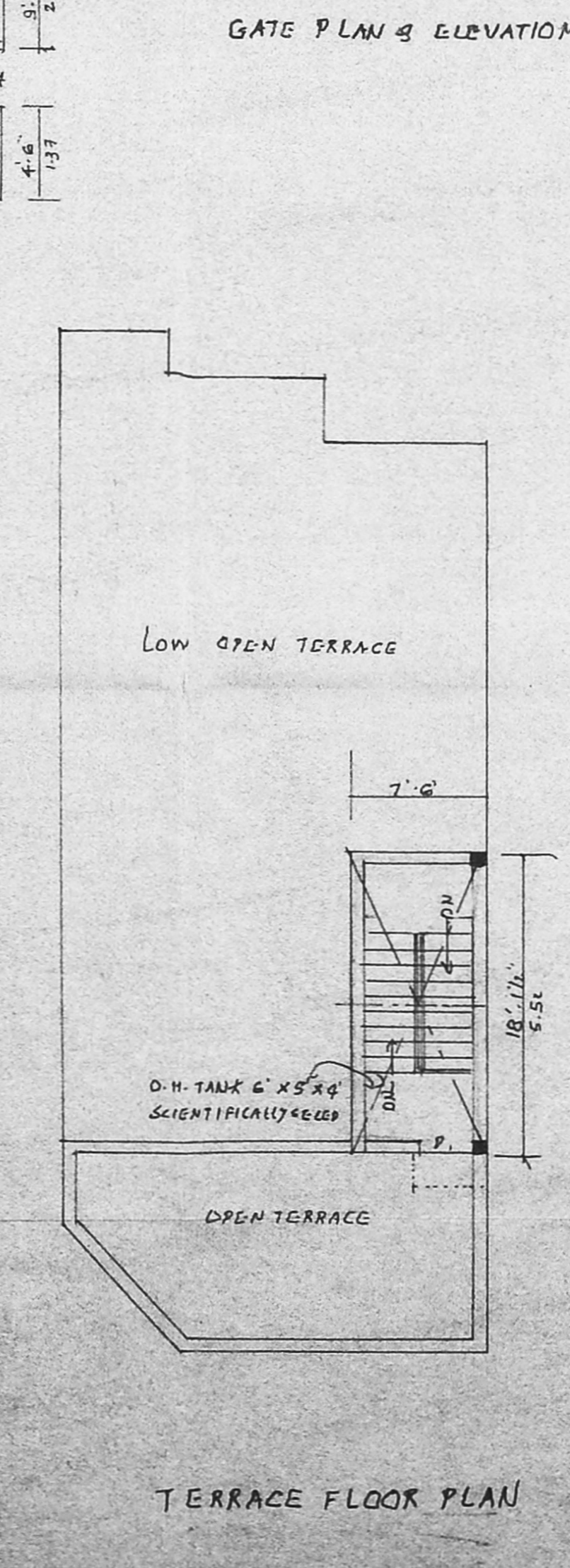
SITE CUM STILT CUM GROUND FLOOR PLAN
