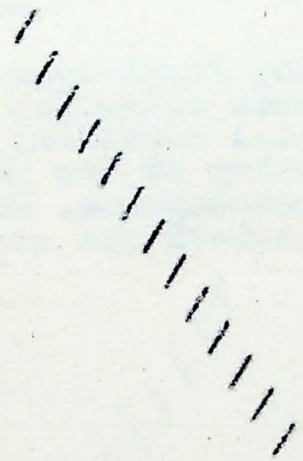
- iii) Regularisation charges : Rs.
