- i) Security Deposit are refundable amount without interest on claim, after issue of completion certificate by CMDA. If there is any deviation/violation/change of use of any part or whole of the building/site to the approved plan Security Deposit will be forfeited.
- ii) Security Deposit for display board is refundable when the display board as prescribed in the format is put up in the site under reference. In case of default Security Deposit will be forfeited and action will be taken to put up the Display Poard.
- iii) In the event of the Security Deposit is not claimed within a period of 5 years from the date of remittance, the Security Deposit shall be forfeited without any further notice.
- 2) Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Sculity Deposits).
- 3) The apers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
  - 4) You are also requested to comply the following:
- a) Furnish the letter of your asseptance for the following conditions stipul ted by virtue of provisions available under DCn 2(b) II:
  - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.

- ii) In cases of Special Buildings, Group Developments, a professionally qualified Architect Registered with Council of Architects or Class-I Licensed Surveyor shall be associated with the Construction work till it is completed. Their names/addresses and consent letters should be furnished.
- iii) A report in writing shall be sent to OMDA by the Architect/ Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached up to plinth level and thereafter every three menths at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- The owner shall inform CMDA of any change of the Licensed Surveyor/Architect. The newly appointed licensed Surveyor/Architect shall also confirm to MDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction exit of the previous Architect/Licensed Surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not obtupy the building or permit it from CMDA.
- wi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/
- vii) When the site under reference is transferred by way of Sale/
  Lease or any other means to any person before completion
  of the construction, the party shall, inform CMDA of such
  transaction and also the name and address of the persons
  to whom the site is transferred immediately after such
  transaction and shall bind the purchaser to those
  conditions to the planning permission.
- viii) In the Open Space within the site, trees should be planted and the existing trees preserved to the extent possible.

- ix) If there is any false rtatement suppression or any misrepresentations of action the application planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
  - x) The new building should have mosquito proof over head tanks and wells.
- ii) The sanction will be void abinitic if the conditions mentioned above are not complied with:
- xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
  - a) Undertaking (in the format prescribed in Annexure-XIV to DCA) a copy of it enclosed in & 10/- stamp paper duly executed by all the land owners, GPA Holders, buildings and promoters separately. The undertakings shall be duly attested by a Notary Public.
  - b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.
- 5) You are also requested to furnish a Demand Draft drawn in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board, Chennai-2 for a sum of Rs. 42,000/- (Rupes Forty two thousand only)

towards water supply and sewerage infrastructure improgement charges. The water supply and sewerage infrastructure improvement charge (a statutory levy) is levied under the provisions of Sec 6(xii)a of CMWSSB Amendment Act 1998 read with Sec 81 (2) (jj) of the Act. As per the CMWSSB Infrastructure Development Charge (levy & Collection) degulation 1998 passed in CMWSSB resolution No.416/98, CMDA is empowered to collect the amount on behalf of CMWSSB and transfer the same to CMWSSB.

- 6) You are also requested to furnish the revised plans rectifying the following defects and the particulars:
- e) i) Site dimensions as on site do not tally with the patta dimensions. Therefore, site plan is to be drawn showing both the dimensions as per patta and as on site with correct conversion into metric form distinguishing the difference by hatching and indicating the set back dimensions from the least dimension like, satisfying DC rules and tallying the building plans set back dimensions with that of least site dimensions.
  - ii) Breaking dimension shown in Ground floor & typical floors do not tally on the western side with the overall dimension.
  - iii) Cross sectional plan AA needs correction, since do not tally with the detailed floor plans.
    - iv) Grading of 1 in 20 was not shown in the set back spaces towards the pebble trench.
    - v) Lift machine room dimensions were not mentioned.
  - vi) Sump capacity shall be restricted to 1000 L/O.U.

- vii) The projections shown adjacent to the windows shall be shown as 'Architectural projections'.
- b) Copy of sanctioned demolition plan for the existing structure issued by Corporation of Chennai shall be submitted.

The issue of Planning Permission depend on the compliance/fulfilment of the conditions/payments stated above. The acceptance by the Authority of the pre-payment of the Development Charge and other charges, etc. shall not entitle the person to the planning permission, but only refund of the Development Charge and other charges (excluding Scrutiny fee) in case of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCK, which has to be complied before getting the planning permission or any other person provided the construction is not commenced and claim for refund is made by the applicant.
