Sub: CMDA - Planning permission - Proposed construction of stilt parking floor + 3 floor office building at Door No.167,168,169 Anna Salai, T.S.Nos.19/1,2, 20,22 and 23/2, Block No.8 of Adyar, Chennai - Approved - Regarding.

The Planning Permission Application/revised plan received in the reference 1st and 2nd cited for the construction of stilt parking floor + 3 floors office building at Door No.167, 168,169, Anna Salai, T.S.Nos.19/1,2,20,21,22 and 23/2, Block No.8 of Adyar has been approved subject to the condition incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Challan No.B 10902 dated.13.6.2002 and B 16750 dated.21.1.2003 including Security Deposit for building Rs.63,300/- (Rs.60,000 + Rs.3,300) (Rupees sixty three thousand and three hundred only) and security Deposit for Display Board of Rs.10,000/- (Rupees Ten thousand only) in cash.

3.a) The applicant has furnished a Demand Draft infavour of Managing Director, Chennai Metropolitan water supply and Sewerage Board for a sum of Rs.78,500/- (Rupees seventy eight thousand and five hundred only) towards water supply and sewerage and infrastructure improvement charge in his letter dated.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.


c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confirmed to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed for with properly protected vents to avoid mosquito menace.

4. Non provision of Rain water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violations of DCR, and enforcement action will be taken against such development.

5) Two copies/sets of approved plans numbered as planning permit No.B/Special Building/58/2002 dated. 29.1.2003 are sent herewith. The planning permit is valid for the period from 29.1.2003 to 28.1.2006.

6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
