- iii) A report in writing shall be sent to CMDA by the Architect/ Class-I Licensed Surveyor who supervises the construction just before the commencement of the crection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached up to plinth level and thoreafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform CMDA of any change of the Licensed Surveyor/Architect. The newly appointed bicensed Surveyor/Architect shall also confirm to AMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a complete sertificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department/Beard/Agency.
- vii) When the site under reference is transferred by way of Sale/ Lease or any other means to any person before completion of the construction, the party shall, inform CMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.
- viii) In the Open Space within the site, trees should be planted and the existing trees preserved to the extent possible.

- ix) If there is any false rtatement suppression or any misrepresentations of action the application planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
- \mathbf{x}) The new building should have mosquito proof over head tanks and wells.
