The Planning Permission Application received in the reference cited for the construction of Stilt+Second Floor (part) with 4 dwelling units residential building at Door No.7, 4th Street, Gopalapuram, Chennai-600 086 in R.S.No.82/16, Block No.4 of Mylapore Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.
