This amount of interest shall be remitted along with the charges due.
  - 4. You are also requested to comply with the following:
- a) Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
- b) 5 copies of Revised Plan rectifying the sectional elevation to scale duly signed by owner/L.S. to be submitted.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
