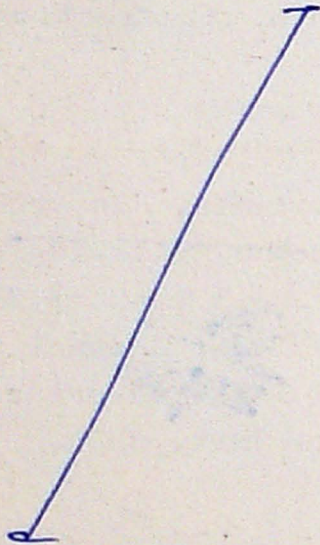
iv) Open Space and Reservation : Rs. 11,000/- (Rs eleven Th only) ✓
