The Planning Permission Application received in the reference cited for the construction of Ground, First and Second Floor (part) with Stilt Floor Residential Building with 4 dwelling units at Door No.8/133, Luz Church 1st Street in R.S.No.1654/26 and 1654/27, Block No.34 of Mylapore Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.
