The Planning Permission Application received in the reference cited for the construction of Ground Floor Residential Building at Door No.10, Chakrapani Street in T.S.No.10/20 (part), Block No.3 of Velachery Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.

- iv) 'Non provision of Rain Water harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to approved plan and violation of DCR and Enforcement action will be taken against such development'.
