The planning permission application/Revised plan received in the reference cited for the construction of Ground Floor, First Floor and Second Floor (part) with stilt floor with 4 dwelling units residential building at the above referred site at Plot No.14B, Ramanujam street, in T.S.No.5945(part), Block No.132 of T. i) Development charges for land and building

: Rs.7,400/-(Rupees Seven thousand four hundred only)

ii) Scrutiny fee

: Rs.500/- (Rupees Five hundred only)



iii) Regularisation charges

: Rs. NIL

iv) Open space reservation charges

: Rs. NIL

2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

- a) Rain water conservation regulations stipulated by CMDA should be adhered to stricitly.
- b) Five copies of Revised Plan rectifying following defects:
 - i) Titles of floor plan has to be indicated as site/stilt/Ground Floor plan and second Floor plan(part) instead of site/ Ground Floor plan and Second Floor plan.
 - ii) In the title of drawing T.S.No.5945(part) to be indicated instead of T.S.No.5945.
- 111) Rain Water Harvest pit detail i.e. Cross section suit shown.
