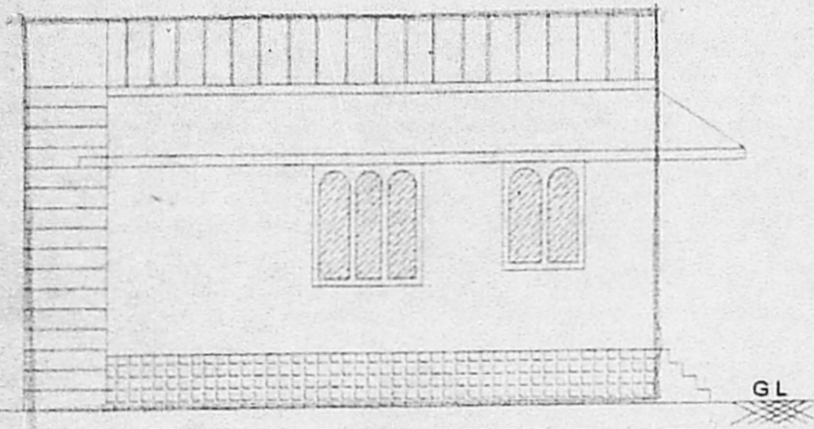


PLAN SHOWING THE PROPOSED RESIDENTIAL BUILDING

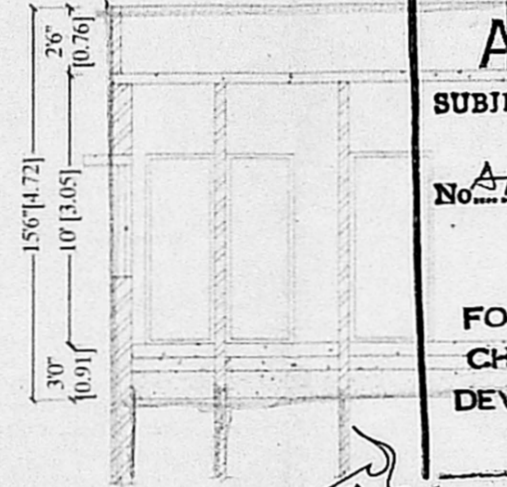

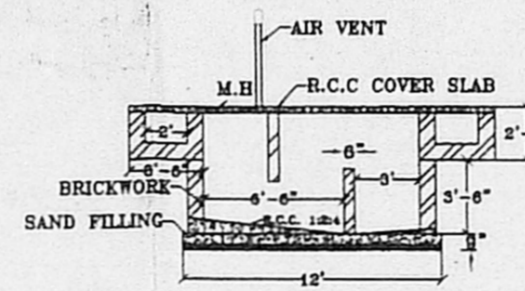

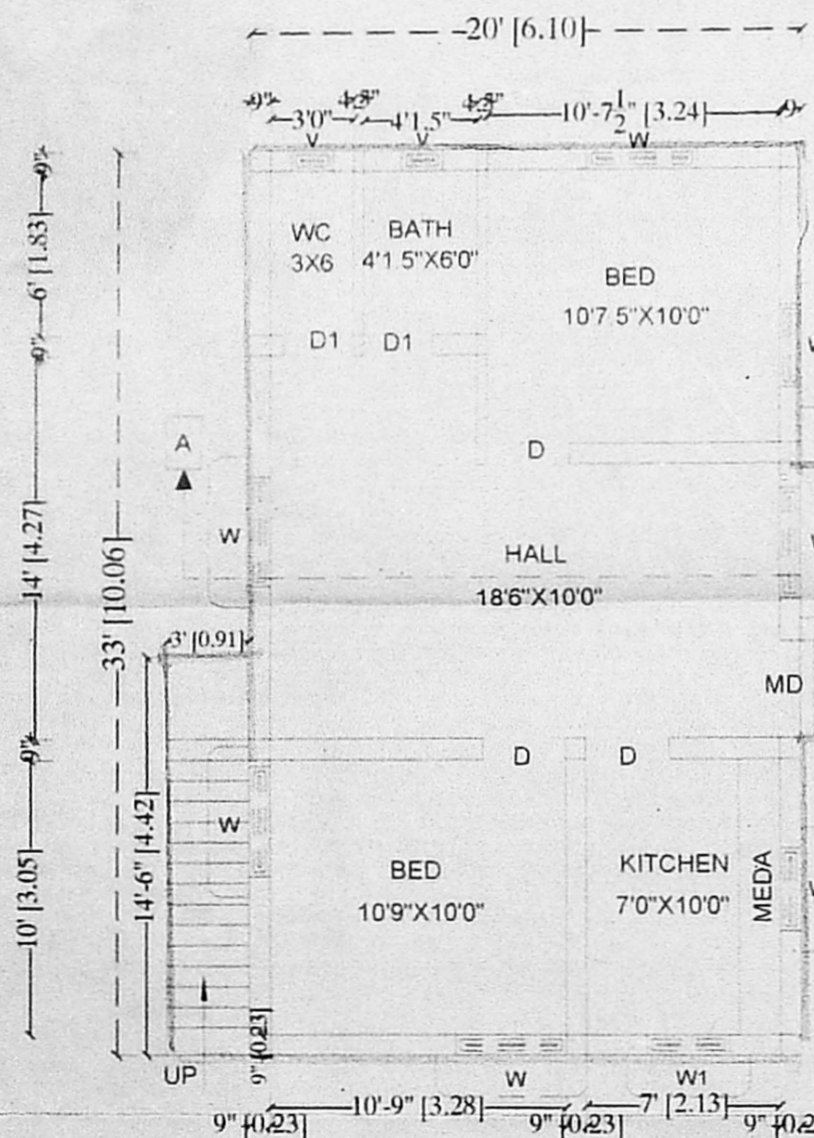

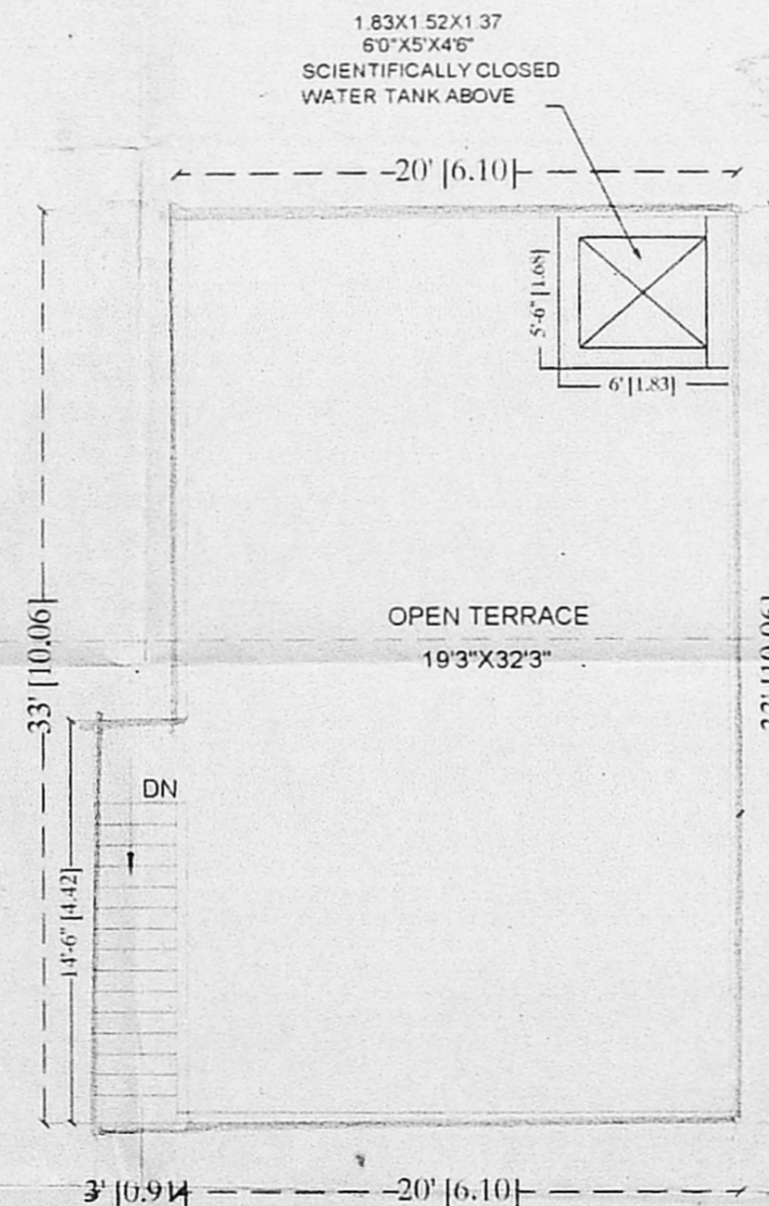
SECTION OF SEPTIC TANK



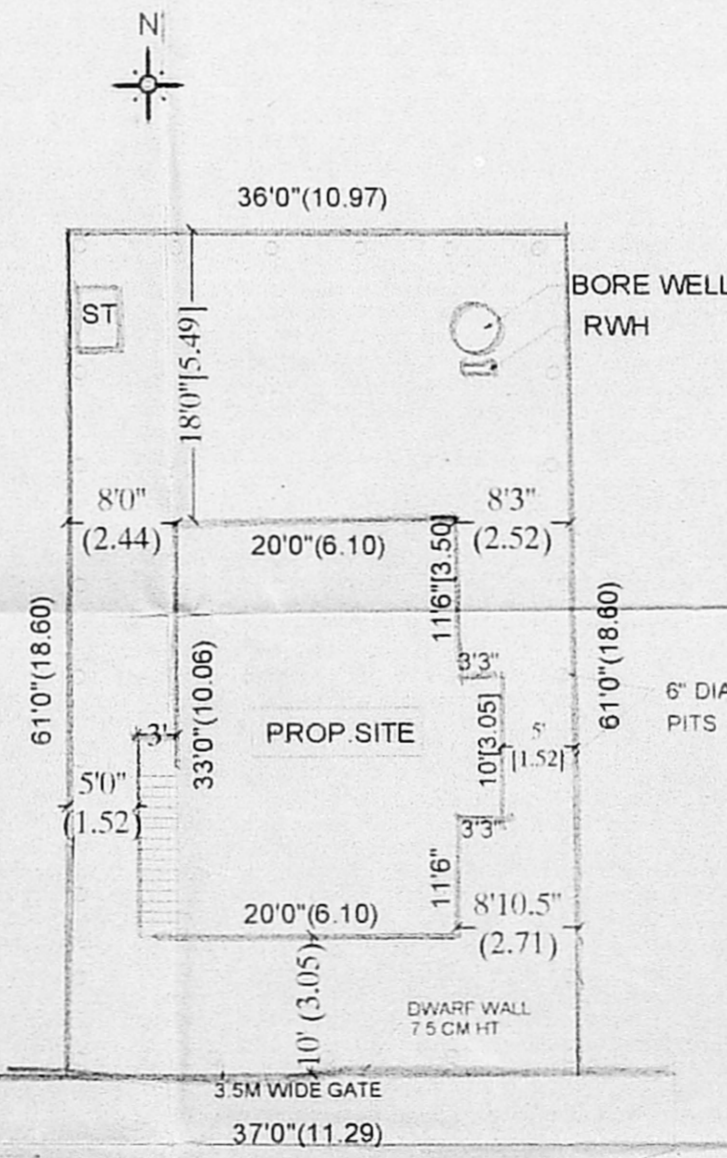

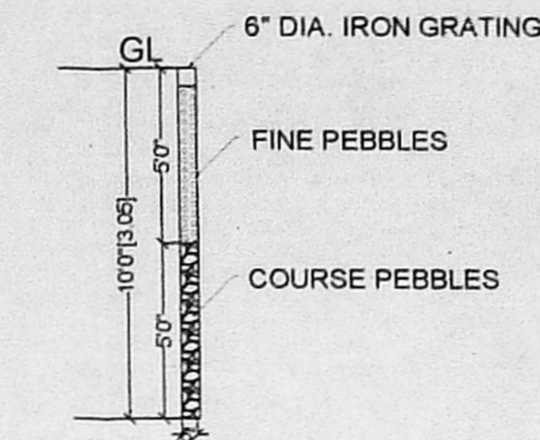
GROUND FLOOR PLAN



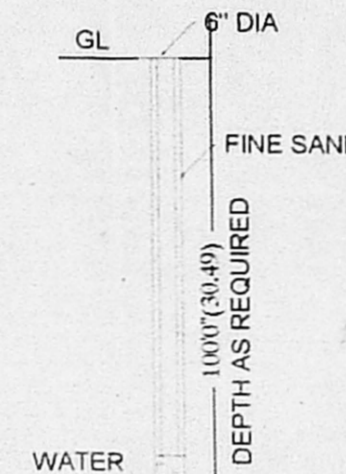
OPEN TERRACE PLAN



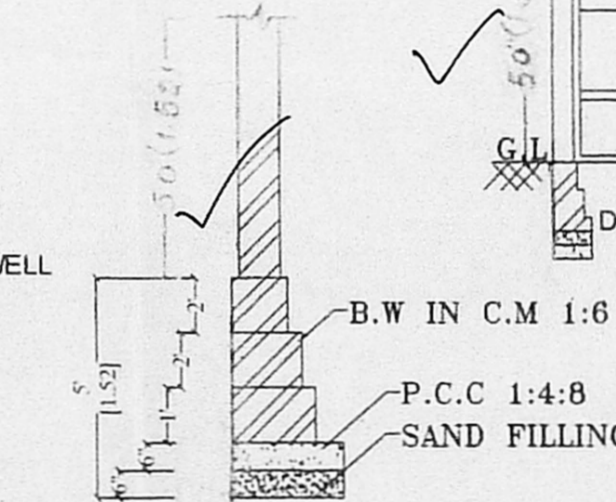
SITEPLAN [1:200]



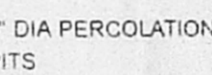
SECTION FOR RAINWATER PERCOLATION PIT



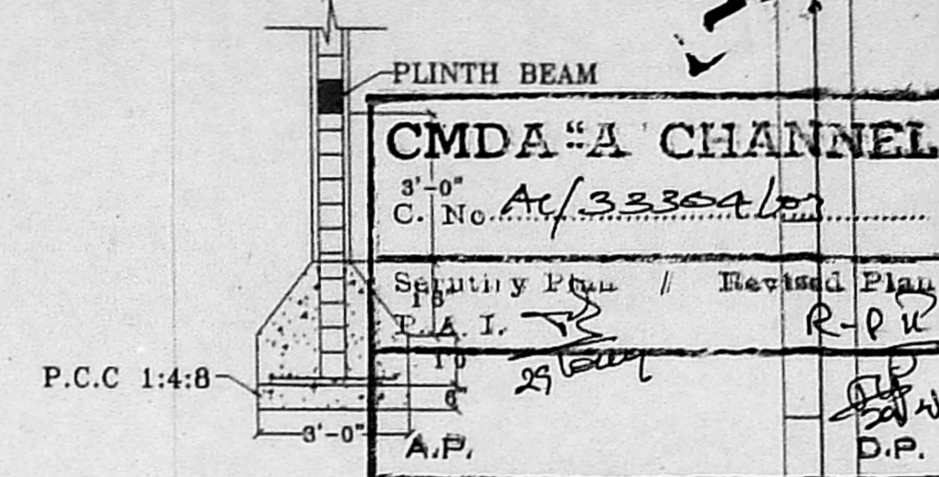
BORE WELL PLAN

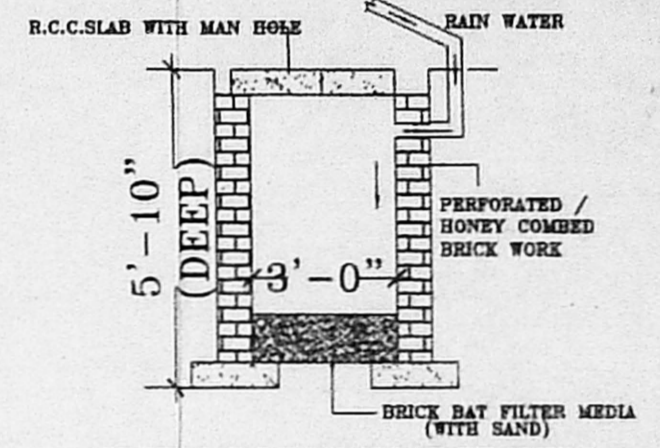


6" DIA PERCOLATION PITS

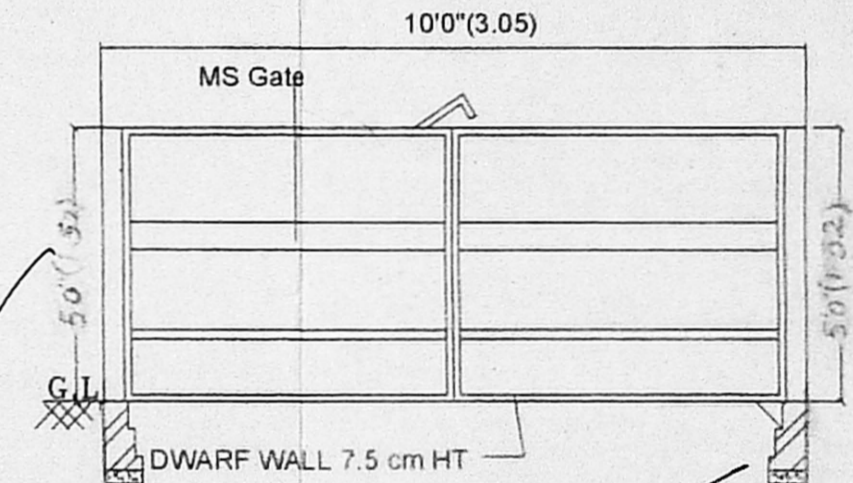


FOUNDATION DETAIL
