2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.



4. You are also requested to comply with the following:

- a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.
- b) 1. **5 copies of Revised plan showing the gate and 7.5 cm. dwarf wall along the gate, width of the gate to be shown in the site plan.**
2. **Residuary plot details should be deleted from the site plan.**
