The Planning Permission Application received in the reference cited for the construction of Ground, First and Second Floor (part) with Stilt Floor Residential Building at Door No.10, Subramaniam Colony, Shastri Nagar in Survey No.142/2 part of Thiruvanniyur Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.
