To process the application further, you are requested to remit the following /charges by/separate Demand Draft of a Scheduled/Nationalised Bank in Chennai City drawn in favour of "The Member-Secretary, CMDA, Chennai-8" at cash counter (between 10.00 AM and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, CMDA.

- i) Development charges for Rs. 6,300/- (Rupees six thousand & three hundred only)
- ii) Scrutiny fee : Rs. 300/- (Rs. three hundred only)
- iii) Regularisation charges : Rs.

- iv) Open Space and Reservation Rs. NIL charges
 - 2. The Planning Permission Application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.
 - 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
 - 4. You are also requested to comply with the following:
 - a) Rain Water conservation Regulations stipulated by CMDA should be adhered to strictly.
 - b) Five copies of Revised Plan showing the titles of the floor plan must be as following "Site/Stilt/GF Plan, S.F. plan (part) instead of Site/stilt/floor plan and second floor plan.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
