- 3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. You are also requested to comply with the following:
 - a) Rain water conservation regulations stipulated by CMDA should be adhered to stricitly.
 - b) 5 copies of revised plan by indicating following:

 - 2) 12'0" passage (Southern-s Service lane) on the southern side of the site to be indicated in the plan.
