Sub: CMDA - **planning Permission - Construction of Basement Floor + Stilt + Second Floor (part) residential building at Plot No.63A, Plot No.7, IIIrd Street, Nandanam Extension, Chennai-600 035. in R.S.No.3884/79, Block No.77 of Mylapore. Development Charges and other charges to be remitted - Regarding.**

The Planning Permission Application/Revised plan received in the reference cited for the construction of Basement Floor + Stilt + Second Floor (part) residential building at the above referred site at Plot No.63A, Door No.7, IIIrd Street, Nandanam Extension, Chennai-600 035 in R.S.No.3884/79, Block No.77 of Mylapore was examined and found approvable.

To process the applicant further, you are requested to remit the following charges by a Demand Draft of a Scheduled/Nationalised bank in Chennai City drawn in favour of 'The Member Secretary, Chennai Metropolitan Development Authority, Chennai -600 008' at cash counter (between 10.00 A.M. and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, Chennai Metropolitan Development Authority.

- i) Development charges for land and building : Rs. **4,600/- (Rupees Four thousand and six hundred only)**
- ii) Scrutiny fee : Rs. **200/- (Rupees Two hundred only)**

- iii) Regularisation charges : Rs. 1
- iv) Open space reservation charges : Rs. 1

2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.

b) 5 Copies of Revised Plan showing:

- i) In the sub-title the floor name to be properly mentioned.**
- ii) Restricting the Floor Space Index to 1.50.**

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
