The Planning Permission Application received in the reference cited for the construction of Ground Floor residential building with one dwelling units at Door No.22B, in T.S.No.1/2, O.S.No.89/2, Block No.10, 3rd Street, Madurasamy Madam, Perambur Sembium Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.
