The Planning Permission Application/Revised Plan received in the reference above cited for the construction of stilt + 2nd Floor part with four dwelling units of residential building at the above referred site at Door No. 14 & 15, Rangarajapuram 6th Street, T.S.No.1/4, R.S.No.79, S.No.1/86 & 1/74, Block No.5 of Venkatapuram Village was examined and found approvable.

To process the applicant further, you are requested to remit the following charges by a Demand Draft of a Scheduled/Nationalised bank in Chennai City drawn in favour of 'The Member Secretary, Chennai Metropolitan Development Authority, Chennai -600 008' at cash counter (between 10.00 A.M. and 4.00 PM) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, Chennai Metropolitan Development Authority.

- i) Development charges for land and building : Rs. **5,600/- (Rupees Five thousand six hundred only)**
- ii) Scrutiny fee : Rs. **500/- (Rupees Five hundred only)**

- iii) Regularisation charges : Rs. **5,500/- (Rupees Five thousand and five hundred only)**
- iv) Open space reservation charges : Rs. **-----**

2. The planning permission application would be returned unapproved, if the payment is not made within 30 d-ays from the date of issue of this letter.

3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:
