The Planning Permission Application received in the reference cited for the construction of Stilt+2nd Floor part with four dwelling units of Residential Building at Boor No.7, Srinivasa Nagar in Survey No.162/2A1A1A1, 1A1A1A1 part of Koyambedu Village was examined and found approvable, as per the plans submitted by the applicant directly to this office.

  - iv) 'Non provision of Rain Water harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to approved plan and violation of DCR and Enforcement action will be taken against such development'.
