2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

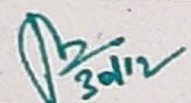

But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

 - ii) Indicating the level of the Low Terrace in in the Terrace floor plan.**
 - iii) Deleting the Balcony projection shown at North east corner.**
 - iv) Showing the entry steps to ground floor.**


5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
