The planning Permission Application received in the reference cited for the construction of Ground Floor & First Floor with one dwelling units residential building at the above referred site at Plot No.14, Old S.No.1, New S.No.1¹⁰⁵ (patta) of Sholinganallur Village was examined and found ^{16¹⁰⁵ 170¹} **approvable.**

To process the applicant further, you are requested to remit the following charges by a Demand Draft of a Scheduled/Nationalised Bank in Chennai City drawn in favour of 'The Member Secretary, Chennai Metropolitan Development Authority, Chennai -600 008' at cash counter (between 10.00 A.M. and 4.00 P.M.) of CMDA and produce the duplicate receipt to Tapal Section, Area Plans Unit, Chennai Metropolitan Development Authority.

- i) Development charges for land and building : Rs. **6,275/- (Rupees Six thousand two hundred and seventy five only)**
- ii) Scrutiny fee : Rs. **500/- (Rupees Five hundred only)**

iii) Regularisation charges : Rs. ----

iv) Open space reservation charges : Rs. ----

2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.


3. However, on specific request from you, an additional time of one month can be considered. But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

4. You are also requested to comply with the following:

- a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.
- b) 5 copies of Revised plan satisfying four car parking lots of size 2.50m x 5.0m and mentioning the approved no correctly in the title.
- c) Copy of the approved layout plan duly attested by Local Body official.

5. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.


