- i) Security Deposits are refundable amount without interest on claim, after issue of completion certificate by CMDA. If there is any deviation/violation/change of use of any part of while of the building/site to the approved plan Security Deposit will be forfeited.

 - i) The construction shall be undertaken as per sanctioned plan only and no decists a front the plans should be made without prior station. Construction done in deviation is liable to be leaded.
 - ii) In cases of Special Buildies from Developments, a professionally qualified meditect Registered with council of Architects or Glass-I Licensed Surveyor shall be associated with the construction work till it is completed. Their manes/addresses and consent letters should be furnished.
 - iii) A report in writing shall be sent to CMDA by the Architects/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/ them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform CIDA of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervision the work under reference and intiate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointee.
 - v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate issued by CMDA also on with his application to the concerned Department/Board/Agency.
- vii) When the site under reference is transferred by way of Sale/lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the make and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purposed to those conditions to the planning permission.

- vili) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible.
 - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
 - x) The new building should have m squite proof over head tanks and wells.
 - xi) The sanction will be avoid abinitic, if the conditions mentioned above are not complied with.
 - xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
 - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs. 10/- stamp paper duly executed by all the land owners, GPA Holders, builders and promoters accountely. The undertakings shall be duly attested by a Notary Public.
 - b) Details of the proposed evelopment duly filled in the format enclosed for splay at the site in cases of Special Buildings and Froup Developments.
