To process the applicant further, you are requested to remit the following by four separate Demand Draft of a Nationalised Bank in Chennai City drawn in favour of Member Secretary, Chennai Metropolitan Development Authority, Chennai -8, at cash counter (between 10.00 A.M. and 4.00 P.M.) in CMDA and produce the duplicate receipt to the Area Plans Unit, 'B' Channel in CMDA.

- NOTE:
- i) Security Deposits are refundable amount without interest on claim, after issue of completion certificate by CNDA. If there is any deviation/violation/change of use of any part of while of the building/site to the approved plan Security Deposit will be forfeited.
- ii) Security Deposit for Display Board is refundable when the Display Board as prescribed in the format is put up in the site under reference. In case of default Security Deposit will be forfeited and action will be taken to put up the Display Board.
- iii) In the event of the Security Deposit is not claimed within a period of 5 years, from the date of remittance, the Security Deposit shall be forfeited without any further notice.
- 2. Payments received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits).
- J. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.

iii) A report in writing shall be sent to CMDA by the Architects/Class-I Licensed Surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached upto plinth level and thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/ them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform CNDA of any change of the Licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervision the work under reference and intiate the stage of construction at which he has taken over. No construction shall be carried on during the period intervening between the exit of the previous Architect/Licensed Surveyor and entry of the new appointee.
 - v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage he/she should enclose a copy of the completion certificate issued by CMDA also on with his application to the concerned Department/Board/Agency.
- Vii) When the site under reference is transferred by way of Sale/lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the make and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purposed to those conditions to the planning permission.

- viii) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible.
 - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
 - x) The new building should have mosquito proof over head tanks and wells.
 - xi) The sanction will be avoid abinitic, if the conditions mentioned above are not complied with.
 - xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
 - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs.10/- stamp paper duly executed by all the land owners, GPA Holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
 - b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings an Group Developments.

5. You are also requised to furnish (a) Demand Draft drawn in favour of Managing Director, Chennal Metropolitan water supply and Sewerage Board, Chennal -2 for a sum of Rs. 83,500/-

(Rupees eighty three thousand five hundred only) improvement towards water supply and sewerage infrastructure improvement charge (a staturcty low) is levied under the provisions of Sec.6(xii)a of CRIBE Infrastructure with Sec.81(2)(jj) of the Act. Is er the CRIBES Infrastructure Development charge (levy and collection) Regulation 1998 passed in CMWSSB resolution No.416/98, CLDA is empowered to collect the amount on behalf of CMWSSB and transfer the same to CMWSSB.

6) You are also requested to furnish 5 copies of revised plan rectifying the following defects.

i) The met set backs shall be indicated at all the members corners/offsets/edges of building perpendicular to least site dimension line.

- 11) Building plus set back dimensions east to west on both sites do not tally with the least site dimension. Hence, the side set back marked as 4,23m shall be corrected as 4,22m.
- iii) 'Ducts' shall be indicated mentioned in the 3rd floor plan alongwith the dimensions.

iv) In the area statement, plot areas and floor areas need correction.

v) Sump capacity shall be restricted to 1000litre/dwelling unit. vi) Elevation and cross sectional plan need marginal corrections.

vii) In the title of the plan, Door Nos. shall be specifically indicated as "Old Door No.3" and "New Door No.5".

viii) The dimensions for the Overhead Tank for recycled sullage water shall be indicated and the height of bottom slab of OHT shall be indicated not exceeding 5.0 from the terrace floor.

im) 'Door' to Staircase Head Room shall be indicated in the terrace floor plan.

The issue of planning permission depend on the compliance/fulfilment of the conditions/payments stated above. The acceptance by the Authority of the prepayment of the Development charge and Other charges etc., shall not entitle the person to the planning permission but only refund of the Development charges and Other charges (excluding Scrutiny fee) in case of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before cetting the planning permission or any other person provided the construction is not commenced and claim for refund is made by the applicant.
