To process the applicant further, you are requested to remit the following by four separate Demand Draft of a Nationalised Bank in Chennai City drawn in favour of Member-Secretary, Chennai Metropolitan Development Authority, Chennai -3, at cash counter (between 10.00 A.M. and 4.00 P.M.) in CMDA and produce the duplicate receipt to the Area Plans Unit, 'B' Channel in CMDA.

- Security Deposits are refundable amount without interest on claim, after issue of completion certificate by CMDA. If there is any deviation/ violation/change of use of any part of while of the building/site to the approved plan Security Deposit will be forfeited.
- ii) Security Deposit for Display Board is refundable when the Display Board as prescribed in the format is put up in the site under reference. In case of default Security Deposit will be forfeited and action will be taken to put up the Display Board.
- iii) In the event of the Security Deposit is not claimed within a period of 5 years, from the date of remittance, the Security Deposit shall be forfeited without any further notice.
- 2. Payments received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Deposits).
- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.

4. You are also requested to emply the followings

- a) Furnish the letter of your receptance for the following conditions attpulated by virture of provisions available under DCR 2(b) III
 - The construction shall be undertaken as per assettoned plan only and no deviation from the plans should be unde without prior smettin. Construction done in deviation is liable to be donoblessed.
 - ii) In cases of Special Buildings, Group Developments, a professionally qualified Architect Registered with cascall of Architects or Class -I Licensed Durweyor shall be associated with the construction work till it is completed. Their names/addresses and consunt letters should be furnished.
 - Architoots/Clans -I Licensed Burveyor who supervises the construction just before the consensationed plans arection of the Euliding as per the sensitioned plans Similar report shall be sent to CPTA when the building has received upto plantable to come the construction overy three months at various stages of the construction/ nevelopment curtifying that the vark so for completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority ismediately if the contract between him/ them and the semar/developer has been concelled or the construction is curried out in deviation to the approved plan.

- Iv) The owner shall income CODA of any change of the Licensed Durveyor/Architect. The newly appointed Licensed Durveyor/Architect shall also confirm to CMDA that he has agreed for supervision the work under reference and intimate the stage of construction at which he has taken over. No construction shall be earlied on during the period intervening between the exit of the provious Architect/Licensed Surveyor and entry of the new appointee.
 - v) On empletion of the construction, the applicant shall intimate CODA and shall not occupy the building or purmit it to be occupied until a completion certificate is obtained from CODA.
- vi) While the applicant makes application for sergice orenection such as Electricity, Vater supply, Severage he/she should enclose a copy of the completion certificate issued by CREA, along with his application to the concerned Department/Source/Appenry.
- vii) When the site under reference is transferred by way of Sele/lease or any other manhs to may person before completion or the complement on the complement of the mannetic and also the make and address of the persons to whom the site is transferred immediately after much transmetion and shall bind the purposed to those conditions to the planning permission.

- viii) In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible.
 - ix) If there is any false statement, suppression or any misrepresentations of acts in the application, planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorised.
 - x) The new building should have mosquito proof over head tanks and well's.
 - xi) The sanction will be avoid abinitic, if the conditions mentioned above are not complied with.
 - xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
 - a) Undertaking (in the format prescribed in Annexure -XIV to DCR) a copy of it enclosed in Rs. 10/- stamp paper duly executed by all the land owners, GPA Holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.
 - b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.

5. You are also requested to furnish (a) Demand Draft drawn in favour of Managing Director, Chennai Metropolitan water supply and sewerage Board, Chennai -2 for a sum of Rs. 48.000/-

(Rupees forty eight thousand only) infrastructure improvement oharges. The water supply and sewerage infrastructure improvement charge (a staturety levy) is levied under the provisions of Sec. 6(xii)a of CMWSSB Amendment Act 1998 read with Sec. 81(2)(jj) of the Act. As per the CMWSSB Infrastructure Development charge (levy and collection) Regulation 1998 passed in CMWSSB resolution No. 416/98, CMDA is empowered to collect the amount on behalf of CMWSSB and transfer the same to CMWSSB.

6. You are also requested to furnish 5 copies of revised plans rectifying the following defects and also to submit the following particulars.

1) The Building Plans set backs dimensions east to west on the northern side do not tally with the site dimension. Therefore, the side set back at North-West corner shall be corrected as 4.63mtr. instead of 4.65mtr.

11) Cross sectional plan needs marginal correction.

iii) Grading of 1 in 20 shall be indicated in the set back spaces towards perculation trench.

iv) Terrace floor plan in respect of parapet wall shall be correctly drawn on the eastern side.

v) Door to access terrace floor shall be shown.

vi) Dwarf wall of 75mm height shall be shown across the

gates in the site plan.

vii) Copy of sanctioned building plan issued by Corporation of Chennal for the Plot No.68 vide P.200/70, dated 12-03-1970, duly attested by Corporation Official shall be submitted.

The issue of planning permission depend on the compliance/fulfilment of the conditions/payments stated above. The acceptance by the Authority of the prepayment of the Development charge and Other charges etc., shall not entitle the person to the planning permission but only refund of the Development charge and Other charges (excluding Scrutiny fee) in case of refusal of the permission for non-compliance of the conditions stated above or any of the provisions of DCR, which has to be complied before getting the planning permission or any other person provided the construction is not commenced and claim for refund is made by the applicant.
