The water supply and sewerage infrastructure improvement charge (a staturety levy) is levied under the provisions of Sec.6(xIi)a of SIWSSB /mendment Act 1998 read with Sec.81(2)(jj) of the Act. As per the CINSSB Infrastructure Development charge (levy and collection) Regulation 1998 passed in CMWSSB resolution No.416/98, CMDA is empowered to collect the amount on behalf of CMWSSB and transfer the same to CMWSSB.
