Sub: CMDA - Planning permission - proposed construction of stilt + 4 floors residential building with 11 dwelling units at Door No. 5, Cenotaph road 1st street, Teynampet, R.S.No. 3841/27 and 28, Block No. 76 of Mylapore, Chennai - approved - regarding

The planning permission application/ revised plan received in the reference 1st cited for the construction of stilt + 4 floors residential building with 11 dwelling units at Door No. 5, Cenotaph road 1st street, Teynampet, R.S.No. 3841/27 and 28, Block No. 76 of Mylapore, Chennai has been approved subject to the conditions incorporated in the reference.

2. The applicant has accepted to the conditions stipulated by Chennai Metropolitan Development Authority vide in the reference 2nd cited and has remitted the necessary charges in Chakan No. B-33287 dated 11.6.2004 including security deposit for building Rs. 1,40,000/- (Rupees one lakh forty thousand only) and Security Deposit for Display Board of Rs. 10,000/- (Rupees ten thousand only)

3.a) The applicant has furnished a demand draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs. 1,79,000/- (Rupees one lakh seventy nine thousand only) towards water supply and sewerage infrastructure improvement charges in his letter dated 11.6.2004

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to metro water and only after due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for metro water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal work should be taken up only after the approval of the water application. It shall be ensured that all walls, overheads tank and sump septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4) Non provision of Rain Water Harvest structure as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as planning permit No. B/Spl.Bldg/353 A to D/2004 dated 16.7.2004 are sent herewith. The planning permit is valid for the period from 16.7.2004 to 15.7.2007.

6) This approval is not final. The applicant has to approach the Chennai Corporation for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
