1. The Planning Permission Application / Revised Plans received in the reference cited for the proposed construction of Ground + 3Floor (14 Dwelling Units) Residential Building at Plot No.B-38, 1st Main Road, S.No.589/1, Thiruvendadam Nagar Colony, Ambattur, Chennai-53 has been approved subject to the conditions incorporated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 4th cited and has remitted the necessary charges in Challan No.28334 dated.2.1.2004 including Security Deposit for building Rs.55,000/- (Rupees Fifty five thousand only) Development Charge for Rs.15,000/- (Rupees Fifteen thousand only), Rs.14,000/- (Rupees Fourteen thousand only) found the Security Deposit for Septic Tank and Rs.10,000/- (Rupees Ten thousand only) towards the Display Board Deposit in cash.

3. The Local Body is requested to ensure Water Supply and Sewerage disposal facility for the proposal before issuing Building Permit.

4. Non provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5. Two copies/sets of approved plans numbered as planning permit No.B/Special Building/34/2004 dated.30.1.2004 are sent herewith. The Planning Permit is valid for the period from 30.1.2004 to 29.1.2007.

6. This approval is not final. The applicant has to approach the Municipality for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
