REPLY

The planning permission application/revised plan received in the reference 1st and 4th cited for the construction of stilt floor + 3 floors residential building with 8 dwelling units at Door No. A-26, Karthikayam Salai, Periyar Nagar, T.S.No. 3, Block No. 322, Periyar village, Chennai has been approved subject to the conditions intercalated in the reference 3rd cited.

2. The applicant has accepted to the conditions stipulated by Chennai Metropolitan Development Authority vide in the reference 4th cited has remitted the necessary charges in Challan No. 26733 dated 19.2.2004 including development Charges for land and building Rs. 12,000/- (Rupees twelve thousand only) and Security deposit for building Rs. 48,000/- (Rupees forty eight thousand only) and Security deposit for Display Board No. 10,000/- (Rupees ten thousand only).

3.a) The applicant has furnished a Demand Draft in favour of Managing Director, Chennai Metropolitan Water Supply and Sewerage Board for a sum of Rs. 40,000/- (Rupees forty thousand only) towards water-supply and sewerage infrastructure improvement charges in his letter dated 19.2.2004.

b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

c) In respect of water supply, it may be possible for metro water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lpcd. In respect of requirements of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all walls, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

3) Non-compliance of main Water Harvest structures as shown in the approved plans to the guidelines of the Authority will also be considered as a deviation to the approved Plans and violation of Development Control Rules and enforcement action will be taken against such developments.

4) Two copies of approved plans registered as planning permit No. R/Spl. Regd/69/2004, dated 20.2.2004 are kept herewith. The planning permit is valid for the period from 20.2.2004 to 19.2.2007.

5) This approval is not final. The applicant has to approach Chennai Corporation for issue of building permit under the Local Body Act, ONLY AFTER which the proposed construction can be commenced.

6) Please furnish monthly to Town Hall.

7) Both parties will move and settle any dispute.
