The Planning Permission Application and Revised Plans received in the reference 1st and 3rd cited for the construction of Ground + 3 Floors Residential Building two Blocks of A and B with 12 and 22 dwelling units respectively (Total 34 dwelling units) at Plot No.6/B1, 6/B2, 6/C, 6/E, 6/F1, Saraswathy Nagar, Survey No.471/6, 6 and 7 of Thirumullaivoyal Village has been approved subject to the conditions incorporated in the reference 4th cited.

2. The applicant has accepted to the conditions stipulated by CMDA vide in the reference 5th cited and has remitted the necessary charges in Challan No.32485, dated 13-05-2004 including Development Charge for Land and Building Rs.40,000/- (Rupees forty thousand only), Regularisation Charges of Rs.25,000/- (Rupees twenty five thousand only), Open Space Reservation Charges of Rs.8,57,000/- (Rupees eight lakhs fifty seven thousand only), Security Deposit for Building Rs.1,55,000/- (Rupees one lakh fifty five thousand only) Security Deposit for Banking Display Board of Rs.10,000/- (Rupees ten thousand only) in cash.

3. The Local Body is requested to ensure water Supply and Sewerage disposal facility for the proposal before issuing Building Permit.

4. Non provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5. Two sets of approved plans numbered as Planning Permit No.B/Spl.Bldg./250A to D/2004, dated 31-05-2004 are sent herewith. The Planning Permit is valid for the period from 31-05-2004 to 30-05-2007.
