The planning permission application/revised plans received in the reference 1st and 3rd cited for the construction at plot No. III and IV Krishnaveni Ammal Nagar, S.Nos. 127/2 part 3 part of Ayyappanthangal village has been approved subject to the conditions incorporated in the reference.

2. The applicant has accepted to the conditions stipulated by Chennai Metropolitan Development Authority vide in the reference 5th cited and has remitted the necessary charges in Challan No. B-29385, dated 12.2.2004 including Security Deposit for building Rs. 46,000/- (Rupees forty six thousand only) and Rs. 9,000/- (Rupees nine thousand only) for Security Deposit for septic tank with upflow filter, and Security Deposit for display board of Rs. 10,000/- (Rupees ten thousand only) in cash.

3. The Local Body is requested to ensure water supply and Sewerage disposal facility for the proposal before issuing building permit.

4. Non provision of Rain water harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violations of Development Control Rules and enforcement action will be taken against such development.

5. Two copies of approved plans numbered as planning permit No. B/Spl.Building/79/2004, dated 19.2.2004 and plans are sent herewith. The planning permit is valid for the period from 19.2.2004 to 18.2.2007.

6. This approval is not final. The applicant has to approach the Panchayat Union/Town Panchayat/Township for Issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
