

v) Security Deposit (for the : Rs. proposed development)

(Security Deposit is refundable amount without interest on claim, after issue of Completion Certificate by CMDA. If there is any deviation/violation/change of use of any part or whole of the building/site to the approved plan, Security Deposit will be forfeited. In case of default Security Deposit will be forfeited and action will be taken).

- 2. In the event of the Security Deposit is not claimed within a period of 5 years from the date of remittance, the Security Deposit shall be forfeited without any future notice.
- 3. Payments received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
 - 5. You are also requested to comply the following:
 - a) Rain water conservation measures notified by CMDA should be adhered to strictly.
 - b) Revised Plans, incorporating the provisions of ramp of 1:12; separate toilets; 10% car parking near the entry; 75cms and 90cms hand railing for disabled of required under Development Control Rule 28(A).

6. The issue of planning permission will depend on the compliance/fulfilment of the conditions/payments stated above.
