PERMISSION is granted to the applicant for the construction/alteration of building according to the authorized code of the plan attached hereto and subject to the condition overleaf.

3. The permit expires on 31st June 1979

The building construction work should be completed as per plan before the expiry date. If it is not possible to complete the construction, request for renewing the planning permit should be submitted to Central Municipal Development Authority before the expiry date. If it is not renewed before the expiry date, Planning Permission application has to be submitted for continuing the construction work when the Development Control Rules that may be made in force at that time will be applicable. If the construction already got up to the foundation in the proposed area and in violation of rules, Planning permit will not be issued.
