Reporting the conditions stipulated by CHID with in the reference  
of the Order and furnished Bank Guarantee for a sum of  
Rs. 10,000/- (Rupees ten thousand only) towards Security Deposit for building/structure  
which is valid upto 4/3/2008 with effect from 01/01/2008  
from Ratan Wada Road No. 7, Pimpri, Chinchwad, PP Distt. or  
3. The promoter has to submit the necessary authority of land  
acquisition directly to Ratan Wada and only after the acquisition is completed  
he can commence the intended construction.

In respect of water supply, it may be possible for the promoter to get  
natural water supply to a single pump for the above premises for the  
purpose of drinking and cooking only and confined to 5 persons per  
dwelling at the rate of 10 liter. In respect of requirements of water  
for other uses, the promoter has to ensure that there are no such
