Area Plans Unit, CMDA.

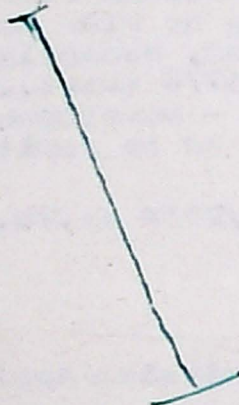
