2. The planning permission application would be returned unapproved, if the payment is not made within 30 days from the date of issue of this letter.

But it will attract interest at the rate of 12% per annum (i.e. 1% per month) for every completed month and part thereof from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.


4. You are also requested to comply with the following:

a) Rain water conservation regulations stipulated by CMDA should be adhered to strictly.


b) 5 Copies of Revised Plan to be submitted by indicating gate location and width, 7.5cm height dwarf wall in the site plan.
