The Planning Permission Application received in the reference cited for the construction of Ground Floor and First Floor residential building at Door No.16, Thiruvalluvar Pettai in R.S.No.4113/16, Block No.89 of Mylapore village was examined and found approvable after relaxing minimum plot extent and frontage requirement, as per the plans submitted by the applicant directly to this office.

- iv) 'Non provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to the approved plan and violation of DCR and Enforcement action will be taken against such development.
